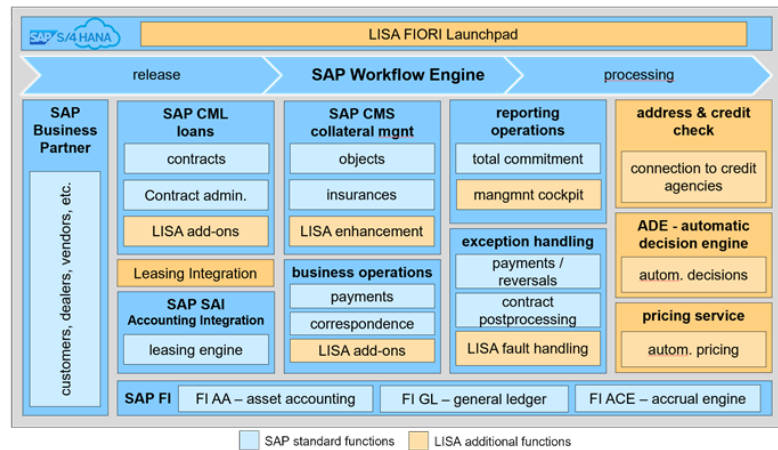

- Use of SAP CML for mapping contracts and conditions
- Objects, insurances and services are managed and evaluated in SAP CMS
- Accounting mapping of leasing transactions via integration in the SAP Leasing Engine (SAI)
- Direct integration with SAP FI General Ledger and Asset Accounting
